CALL TO ORDER

The Reconvened Annual Meeting of the Membership of the Sierra Pointer Homeowners Association, Inc was held via Zoom conference call. The meeting was called to order at 6:03 p.m. by John Clancy.

ELECTION OF THE BOARD

Heather Smith shared the results page of the Election Buddy website and announced the election results as follows:

- a. John Clancy is elected to the Sierra Pointe of Directors with a two-year term.
- b. Holly Schwarz and Patricia Guerin each received the same number of votes, resulting in a tie. Heather Smith explained that the community could either 1) hold a true-off election to determine a winner between Holly Schwarz and Patricia Guerin; or 2) the Board could allow one candidate to be elected to the full two-year term while appointing the other candidate to the vacant position on the Board, which has one-year remaining in its term. The floor was open for discussion. Patricia Guerin was not present on the meeting, so she was contacted by phone for input. Both Patrica and Holly agreed that Holly Schwarz should occupy the two-year term, while Patricia Guerin occupies the one-year term.
- c. **Board Action:** A **motion** was made by Orlando Rodriquez and seconded by Rebecca Allen to appoint Patricia Guerin the vacant position on the Board of Directors with one-year remaining in the term. Motion carried.
- d. With Patricia Guerin appointed to the Board and no longer an active candidate, Holly Schwarz was elected to the Board of Directors with a two-year term.
